A resolution requesting the Louisiana Department of Transportation & Development to install a traffic light at the intersection of Airline Highway and Evangeline Road in Montz.

WHEREAS, Evangeline Road is the primary means of traveling to Airline Drive for residents of Montz traveling to and from their jobs; and.

WHEREAS, Evangeline Road is used daily by the school buses transporting students to and from school; and,

WHEREAS, with the open span of roadway from the traffic lights at Apple Street in Norco and McReine Road in Montz, and with enormous amount of traffic, it has created a very dangerous and difficult situation for vehicles entering Evangeline Road from Airline Drive and vehicles turning onto Airline Drive from Evangeline Road, causing a tremendous traffic back-up on Evangeline Road; and,

WHEREAS, large trucks use this span of roadway to access the Bonnet Carre Spillway; and,

because of the conspicuous location of Evangeline Road when traveling east bound, traffic must slow down causing a potential hazardous condition for east bound traffic.

NOW, THEREFORE, BE IT RESOLVED, THAT WE, THE MEMBERS OF THE ST. CHARLES PARISH COUNCIL, do hereby request that the Louisiana Department of Transportation & Development install a traffic light at the intersection of Airline Highway (US 61) and Evangeline Road in Montz.
