As a resident of Mimosa Park, I'm deeply concerned about the recent construction of housing on 50-foot lots with excessively high roofing. This development appears to exploit loopholes in our ordinance R1AV6, posing potential hazards to fire safety, parking, and neighborhood aesthetics. I urge you to personally inspect the 200 and 300 blocks of Mimosa winda Signature and Sig Park to see the impact.
