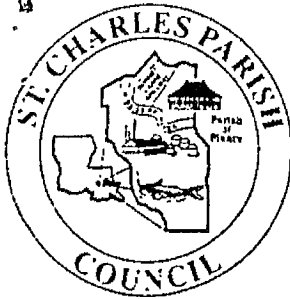

A copy of Resolution No. 4854 authorizing this offer of no objection is enclosed for your records.

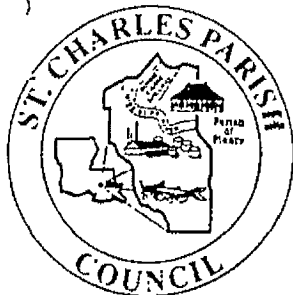

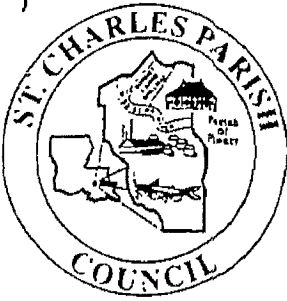
