PLEASE TAKE NOTICE that by virtue of a written contract dated October 5, 2016, St. Charles Parish, 15045 River Road, P.O. Box 302, Hahnville, LA 70057, through its Parish President, Larry Cochran, duly authorized by Ordinance No. 16-10-4 adopted by the St. Charles Parish Council on October 3, 2016, and E3 Electrical, Inc. 1001 Lafayette Street, Houma, Louisiana 70363 through Stanley B. Whitney, III, President, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner by installing a new generator for the existing St. Charles Parish Planning and Zoning building in St. Charles Parish, Louisiana for the price and sum of ONE HUNDRED SEVENTY FOUR THOUSAND, FOUR HUNDRED THIRTY (\$174,430.00) DOLLARS AND 00/100, the work under the Contract to be completed within one sixty four (164) calendar days from the date of the Notice to Proceed. Said basic work described as follows: Provide a new generator for the existing building according to the Drawings, Specifications and Contract Documents for SCP Project #FEMA-1603-DR-LA-0079, St. Charles Parish Planning and Zoning Generator, as prepared by Huseman & Associates, LLC, dated May 26, 2016. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described new construction is generally described as St. Charles Parish Planning and Zoning, 14996 River Rd., Hahnville, Louisiana. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
