Why does the Council want to purchase this site which is across the street from M-1 zoned property which already has an existing facility which stores chlorine gas on site from time to time?

Why does this Council want to provide a site that is completely wooded that will cost the taxpayer a substantial amount of money to remove the trees and stumps to an offsite location?

Why does this Council want to purchase a piece of property that is an old slough that flood every time it rains and that will cost the taxpayers a substantial amount of money to fill to make it useable?

Why did this Council and especially Councilman Walls refuse to answer my questions for the last four months on what the total cost would be to purchase, clear, and fill the site?

Is it because it would show that the total cost would be well above the Parish's cost to purchase the property I offered?

Is it because it would end up costing Councilman Wall's uncle the sale of the J.B. Green site?

Is there any other reason why Councilman Walls would adamantly refuse to find out what the total cost would be?

Should the Parish purchase property that is not in the best financial interest of the taxpayers?

Should the Parish purchase property before it confirms that it's not in the best interest of the taxpayers?

Why has Councilman Walls refused to sit with me to discuss this issue as I requested of him since he took office?

Is it because to do see the light and to do the right thing would end up costing Councilman Wall's uncle the sale of the J.B. Green site?

I offered to sell the 50 year old 2-1/2 acre Old Spanish Trail Ballpark that the community wants for \$51,400 along with me giving a charitable donation equal to the difference in that price and what the property is worth today. Its cleared and ready for immediate use with no additional cost. It does not flood. Its what the community wants.

Why has this 4-month old offer never been considered or discussed with me?

Why was the meeting to discuss and try to work thing out never held with me?

Is this proposed purchase being done out of spite?

Name one positive physical characteristic about the J.B. Green site compared to the site I offered?

Name one positive financial aspect about the J.B. Green site taking into consideration what it will cost to improve the site as compared to cost of the site I offered?

The purchase of this property is not in the best interest of this community as they told you in a petition with over 70 signatures back in May and as they told you once again at the October 18 Council meeting. This Council chose to ignore them each time. The purchase of this property is not in the best interest of the taxpayers as my offer proves. The only possible way this Council can possible try and justify this site as being in the best financial interest of the taxpayers would be to claim that it will not cost any additional money because the Parish can clear and fill the site using Parish personnel. For that to be the case, it would mean that the workers work for free, the trucks and equipment were free, the fuel is free, the insurance is free, the supervision is free, the disposal of the trees and stumps in a landfill is free, the dirt to fill the site is free, and so on.

Since none of this stuff is free, the total cost would have to be less that \$13,200 for this to be the better deal. But how can it be? Just the dirt needed to fill the site will cost twice that much.

The site I offered was used as a ballpark by the community for over 50 years. It's cleared. It does not flood. It has people living all around it. It's centrally located. It's what the community wants. It's the all around better deal that this Council seems to refuse to want to accept out of spite or due to the relationship with the J.B. Green property owner. There is no other logical reason!

This Council needs to get over any hang-ups it has and do what's best for this community and the taxpayers.

And lastly, If this passes, the three people that the community can thank and needs to remember for not saving the Old Spanish Trail Ballpark is our past Councilman Terry Authement, our current Councilman Derryl Walls, and Reverend Mitch Bolden of the Antioch Baptist Church.
