who, after being duly sworn, did acknowledge and declare that they are the members of Jones Construction Solutions, LLC, organized under the laws of the State of Louisiana, whose Articles of Organization are recorded in the office of the Louisiana Secretary of State, and that these Articles of Organization provide that, Caleb Jones and/or Jessica Jones, are authorized to act on behalf of said Jones Construction Solutions, LLC. At this meeting on said date, the members of Jones Construction Solutions, LLC decided by unanimous action as follows:

- a.
