ORDINANCE NO. 09-1-11

An ordinance to approve and authorize the execution of an Agreement between Egle' Associates and St. Charles Parish for government affairs representation before the Federal Government.

WHEREAS, it is in the best interest of St. Charles Parish that direct representation be provided in Washington, DC for services before the Federal Government, including Congress, the Administration, and any agency deemed necessary for the success of the Parish in securing Federal funding; and,

WHEREAS, it is the desire of St. Charles Parish to engage Egle' Associates, 1625 Beulah Road, Vienna, Virginia, to provide said services for St. Charles Parish.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the Agreement for services between Egle' Associates and St. Charles Parish is hereby approved.

SECTION III. That the Parish President is hereby authorized to execute said Agreement on behalf of St. Charles Parish.

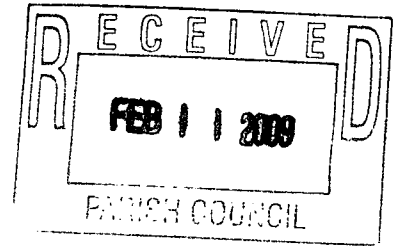

Pursuant to our discussions, I am submitting, for your approval, terms of a working agreement between St. Charles Parish and Eglé Associates. The terms of the agreement are as follows:

11/31/10
This agreement will extend over a 12-month period beginning ^{*11/21/09*}~~8/45/08~~ and terminating ^{*2/1/09*}~~8/44/09~~. It would be automatically renewed for an additional one-year period unless terminated by either party.

Eglé Associates agrees to provide St. Charles Parish with government affairs representation and lobbying service before the federal government – Congress, the Administration and any agency deemed necessary for the success of the objective of this initiative.

St. Charles Parish agrees to pay Eglé Associates \$8,333.00 per month, plus normal business expenses which shall not exceed \$1,000/month without the advance approval of V.J. St. Pierre, Jr., Parish President or his designee.

Eglé Associates shall submit an invoice on the first of each month for the monthly retainer and itemized expenses to St. Charles Parish. Such invoices shall be paid within fifteen (15) days of invoice date.


Eglé Associates agrees to abide by every applicable law or regulation covering government contracts for lobbying during the implementation of this agreement. Eglé Associates is an independent contractor, and, as such, has no authority to bind St. Charles Parish, in any manner whatsoever, absent to the express written consent of St. Charles Parish. Eglé Associates shall be solely responsible for the acts of its employees and/or agents and shall defend and hold St. Charles Parish harmless from any claims that arise from said acts.

St. Charles Parish has no authority to bind Eglé Associates in any matter whatsoever, absent the express written consent of Eglé Associates. St. Charles Parish shall be solely responsible for the acts of its employees and/or agents and shall defend and hold Eglé Associates harmless from any claims that arise from said acts.
