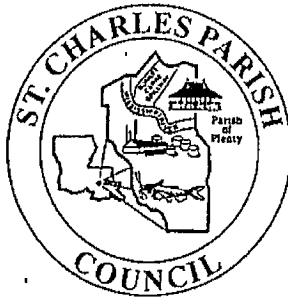

A copy of Resolution No. 5407 authorizing this offer of no objection is enclosed for your records.

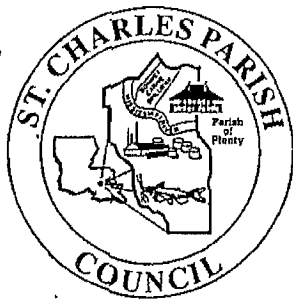
