Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 21-1-2, adopted by the St. Charles Parish Council on January 11, 2021, and BLD Services, LLC, 2424 Tyler Street, Kenner, LA 70062, through Brent Albert, Project Manager, entered into a contract to furnish all the materials, supplies, machinery, equipment, tools, superintendence, labor, insurance, and other accessories and services necessary to complete said project: Lone Star Sewer Rehabilitation, Project No. S181201, in St. Charles Parish, Louisiana for the price and sum of TWO HUNDRED, EIGHTY EIGHT THOUSAND, TWO HUNDRED FIFTY FOUR DOLLARS AND 00/100 (\$288,254.00).
