PLEASE TAKE NOTICE that by virtue of a written contract dated December 19, 2014, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, V. J. St. Pierre, Jr., duly authorized by Ordinance No. 14-12-13 adopted by the St. Charles Parish Council on December 15, 2014, and Fleming Construction Company, L.L.C. 23 East Airline Drive, Kenner, LA 70062 through Jack D. Fleming, II, Manager/Member, entered into a contract to furnish labor, materials and equipment for the Primrose (Ellington) Canal Road Crossing Culvert Replacement in St. Charles Parish, Louisiana for the price and sum of ONE MILLION NINE HUNDRED NINETY NINE THOUSAND FOUR HUNDRED FIFTY THREE DOLLARS AND 40/100 (\$1,999,453.40) DOLLARS, the work under the Contract to be completed within Three Hundred Sixty (360) calendar days from the date of the Notice to Proceed. Said basic work comprises the replacement of Primrose (Ellington) Canal Road Crossing Culvert as shown on the Drawings, Specifications and Contract Documents for Parish Project No. 090201-3 as prepared by Professional Engineering and Environmental Consultants, Inc., dated August 25, 2104. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is generally describe as located generally along Ellington Canal at Monsanto Avenue, River Oaks Avenue, Oak Lane, Diane Drive, and Lagattuta Blvd., in Luling, in St. Charles Parish, as per the detailed plans and specifications prepared by Professional Engineering and Environmental Consultants, Inc.
