Parishwide Home Rule Charter Amendment Proposition No. 1 of 2

Shall Article III, Section A.2 of the St. Charles Parish Home Rule Charter be amended to read: The members of the parish council elected at large shall receive an annual salary of \$24,000.00 and the members elected by districts shall receive an annual salary of \$19,200.00, effective January 8, 2024. The annual salaries of the parish council, as established herein, shall be adjusted by the same percentage rate as the cost of living adjustment approved for civil service employees in 2025 and each succeeding year thereafter. Each member shall receive his actual and necessary expenses incurred in the performance of his duties, within limitations established by the parish council?

Parishwide Home Rule Charter Amendment Proposition No. 2 of 2

Shall Article III, Section B.2 of the St. Charles Parish Home Rule Charter be amended to read: The annual salary of the parish president shall be fixed at \$175,000.00, effective January 8, 2024, and may be increased by ordinance of the parish council, provided that an ordinance increasing the president's salary shall not be passed during the last year of a term and no salary increase shall become effective during the term in which the ordinance is adopted. The parish president shall be eligible for all benefits available to full-time employees of the Parish?
