An ordinance to approve and authorize the execution of an Amendment to Ordinance No. 98-4-18 between Chenevert, Songy, Rodi, Soderberg and St. Charles Parish for an Amendment to the South Destrehan Avenue Improvements contract for Engineering services.

WHEREAS, Ordinance No. 98-4-18 adopted April 20, 1998, by the St. Charles Parish Council approved and authorized the execution of a contract for engineering services with Chenevert, Songy, Rodi, Soderberg for necessary Professional Services associated with South Destrehan Avenue Improvements, P970705; and,

WHEREAS, the Parish has requested changes to the original project scope that requires additional engineering services to complete the design.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS, to approve and authorize the execution of an Amendment to Ordinance No. 98-4-18 between Chenevert, Songy, Rodi, Soderberg and St. Charles Parish for an Amendment to the South Destrehan Avenue Improvements contract for Engineering Services.

AMENDMENT NO. I
TO
ENGINEERING SERVICES CONTRACT
WITH
CHENEVERT, SONGY, RODI, SODERBERG
(ORDINANCE NO. 98-4-18)

BE IT KNOWN that on this 21ST Day of ~~SEPTEMBER~~ 2000, St. Charles Parish, P.O. box 302, Hahnville, LA. 70057, hereinafter called "Parish", and Chenevert, Songy, Rodi, Soderberg hereinafter called "Engineer" hereby agree that Ordinance No. 98-4-18 is hereby amended to modify the following provisions:

AMENDMENT TO THE CONTRACT FOR ENGINEERING SERVICES

Paragraph 2.1.2 is hereby amended to read as follows:

2.1.2 In general, the Project consists of the Design and Construction Management of the following major elements of the project:

1. The intersection of S. Destrehan Ave and La. Hwy 48 is to be shifted to the east of it's present location to facilitate beautification work. CSRS will work with the beautification committee for their input.
2. The entrance to the school will be modified as part of the intersection relocation. CSRS will work with the designated school officials to achieve this modification.
3. Eleven-foot lane widths will be used from LA Hwy 48 to the south side of St. Francis Street.
4. Drainage structures will be placed under the railroad tracks (jack & bore) and an outfall channel will be constructed from the railroad embankment to an existing improved channel downstream. (approximately 500 feet)
5. The concrete lining of the existing channel is to be removed from the plans.
6. Present Beautification Committee entrance improvements as an Alternate Bid.

The amended opinion of probable project budget is as follows:

Engineering, LADOTD and Railroad Permits	39,784
Surveying (Fee)	3,500
Materials Testing	<u>11,850</u>
TOTAL PROJECT BUDGET	\$838,934

SECTION II. That the necessary funds for the total project budget in the amount of \$838,934 be allocated to the above-described project and appropriated from the Road and Drainage Maintenance and Operations Fund.

All other provisions of said contract shall remain as first written.
