Subject: Commencement of IMTT Pipeline Construction

Mr. Jewell,

IMTT will soon be commencing construction on two pipelines between the IMTT facility in St. Rose and the Diamond Green renewable diesel facility in Norco. Construction is expected to begin sometime in the next 3 to 5 weeks. The two pipelines are fully permitted with all agencies. IMTT has already presented this project to yourself and the council. IMTT is providing this communication as a courtesy to the parish because the official presentation and approval with the parish took place many months ago.

The duration of the pipeline construction is estimated to be 5 months. Both pipelines are 12 inches in diameter. One pipeline will carry renewable feedstock and the other pipeline will transport renewable diesel. Both pipelines will be installed in compliance with all applicable standards and regulations as well as all requirements in the permit from the parish. If you or any of the council have any questions, please feel free to reach out to me. Below my signature is an aerial image showing the routing of the two parallel pipelines represented by the cyan line.
