

NOTICE OF CONTRACT

PLEASE TAKE NOTICE that by virtue of a written contract dated December 7, 2011, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, V. J. St. Pierre, Jr., duly authorized by Ordinance No. 11-12-3 adopted by the St. Charles Parish Council on December 5, 2011 and Aegis Construction, Inc., 456 West 5<sup>th</sup> Street, LaPlace, LA 70068 through M. Kent Liliedahl, President, entered into a contract to furnish all labor, materials and equipment and perform all of the work required to build, construct and complete in a thorough and workmanlike manner, the St. Charles Parish Emergency Operations Center, 15026 River Road, Hahnville, LA for the price and sum of FIVE MILLION EIGHT HUNDRED FORTY FIVE THOUSAND AND 00/100THS (\$5,845,000.00) DOLLARS, the work under the Contract to be completed within Three Hundred Sixty Five (365) consecutive calendar days from the date of the Notice to Proceed. Said basic work to include the construction of all improvements, including Base Bid and Alternate No. 1, as shown on the Construction Drawings and in accordance with the project plans and specifications for FEMA Project No. 2008-EO-T8-0010, FP&C Project No. 50-J45-09-01, St. Charles Parish Emergency Operations Center located at 15026 River Road in Hahnville, Louisiana, as prepared by Duplantis Design Group, PC. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is more fully described as shown on a "Survey of Two Portions of Property Being Purchased By St. Charles Parish in Sections 16 & 17, T13S-R20E St. Charles Parish, Louisiana" prepared by Lucien C. Gassen, PLS dated January 6, 2010, said property having been acquired by St. Charles Parish by Cash Sale from Madere's Garage, Inc., on April 19, 2010, in accordance with Ordinance No. 10-4-10 of the St. Charles Parish Council adopted on April 5, 2010 and filed in the St. Charles Parish Clerk of Court's Office as Entry No. 360415, COB 742 folio 490 on May 4, 2010 AND by Judgment of Expropriation of the 29<sup>th</sup> Judicial District Court, State of Louisiana, No. 71,548-D, Parish of St. Charles vs. Earl P. Gaudet, Jr., ET AL rendered on August 10, 2010.
