ENGINEERING SERVICES CONTRACT

Paragraph 2.1.2 is hereby amended to add the following sub-paragraphs:

- Preparation of DNR and USCOE permits (NTE \$3,572.00)
- Additional engineering required to switch the pumps from natural gas to diesel oil engines from value engineering analysis (NTE \$11,438.00)
- Additional geotechnical work (NTE \$3,080.00)
