9. At intersections of driveways and alleys with streets, no fence hedge, wall, sign, or other structure shall be erected, placed, or allowed to grow in such a manner as to impede vision between a height of two and one-half (2½) feet and ten (10) feet above the established driveway or alley grade level.

(a) No shrubs, trees, and plantings on parish right-of-ways, easements, and servitudes should be allowed to impede the *vehicular* site lines of vehicles travelling on or entering onto parish streets which are located within such right-of-ways, easements, and servitudes.

7. Shrubs and trees.

a) No shrubs or trees shall be positioned to block any vehicular travel sight line.

I concur and I completely agree with you. If the driver is in a corvette or some vehicle that sits lower than a vette, it may be 3' or 2.5'. We probably need to look at the worse case scenario to determine the height the bushes need to be trimmed in order to provide for a clear line of sight.

Thanks for meeting with me today. I passed by the bushes following our meeting where you advised me that you had thought the bushes were cut. They have not been as seen in the attached picture. The top of the fence is 4' and the bushes are clearly shown above the fence height by a lot. The picture shown taken from in the driveway is taken from within a tall F250 and the camera is right on the property line showing the line of sight obstruction to vehicles heading from Barber Road to Highway 90.

Please ask Mark East to have the bushes trimmed to below 4' and if he does not with a reasonable amount of time, then have the publicworks department have the bushes trimmed as the parish can do according to Bobby Raymond when they pose a line of sight obstruction.

Please advise on the plan of action to have these bushes addressed for the safety of those leaving the driveway and that of the motorist travelling on Wisner.
