

**NOTICE OF CONTRACT**

**LABRANCHE SALINITY BARRIER PROJECT PO-43a**

PLEASE TAKE NOTICE that by virtue of a written contract dated May 19, 2016, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Larry Cochran duly authorized by Ordinance No. 16-2-11 adopted by the St. Charles Parish Council on February 15, 2016 and DQSI, LLC 19218 North Fifth Street, Covington, Louisiana 70433, through Shelly Stubbs, President/CEO, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct and complete in a thorough and workmanlike manner the LaBranche Salinity Barrier Project, PO-43a in St. Charles Parish, Louisiana for the price and sum of TWO HUNDRED NINETY-SIX THOUSAND SIX HUNDRED AND NINETY SIX DOLLARS AND 00/00 (\$296,696.00) DOLLARS, the work under the Contract to be completed within one hundred and fifty (150) calendar days from the date of the Notice to Proceed. Said basic work to be comprised of filling of a geotextile tube to reestablish a sill which has settled over time, approximately 465 feet in length, under the I-10 Interstate Bridge at the intersection of Parish Line Canal and the borrow canal for I-10, as shown on the Drawings, Specifications and Contract Documents for the LaBranche Salinity Barrier Project-PO-43a as prepared by Moffatt & Nichol 301 Main Street, Suite 800, Baton Rouge, Louisiana 70801 on December 7, 2015. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is generally described as to be located under the I-10 interstate bridge at the intersection of Parish Line Canal and the borrow canal for I-10 located in St. Charles Parish, Louisiana as per the detailed plans and specifications prepared by Moffatt & Nichol.


