An ordinance to approve and authorize the Parish President to execute a Franchise Agreement with Entergy Louisiana, LLC, (formerly known as Louisiana Power and Light) its successors and assigns, to provide electric power and energy throughout St. Charles Parish all in accordance with La-R.S. 33:4361.

WHEREAS, St. Charles Parish Policy Jury on September 7, 1926, adopted a Franchise Agreement with Louisiana Power and Light to provide electric power and energy throughout St. Charles Parish; and,

WHEREAS, the term of the Franchise Agreement was for a term of ninety-nine (99) years and said Agreement expires on September 6, 2025; and,

WHEREAS, it is imperative that St. Charles Parish continue to provide for the health, safety and welfare of its citizens by continuing to provide said service by entering into the attached Franchise Agreement with Entergy Louisiana, LLC.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. The St. Charles Parish Council hereby approves the attached Franchise Agreement with Entergy Louisiana, LLC, for a term of ninety-nine (99) years.

SECTION II. That the Parish President is further hereby authorized to execute the Franchise Agreement with Entergy Louisiana, LLC, and any and all documents deemed necessary to provide electric power and energy throughout St. Charles Parish.

The foregoing proposed ordinance was postponed indefinitely on February 10, 2025, by the following vote:
