Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 21-2-10 adopted by the St. Charles Parish Council on February 22, 2021, and Omega Foundation Services, Inc., 703 Edgewood Drive, Thibodaux, LA 70301, through Andrew W.
