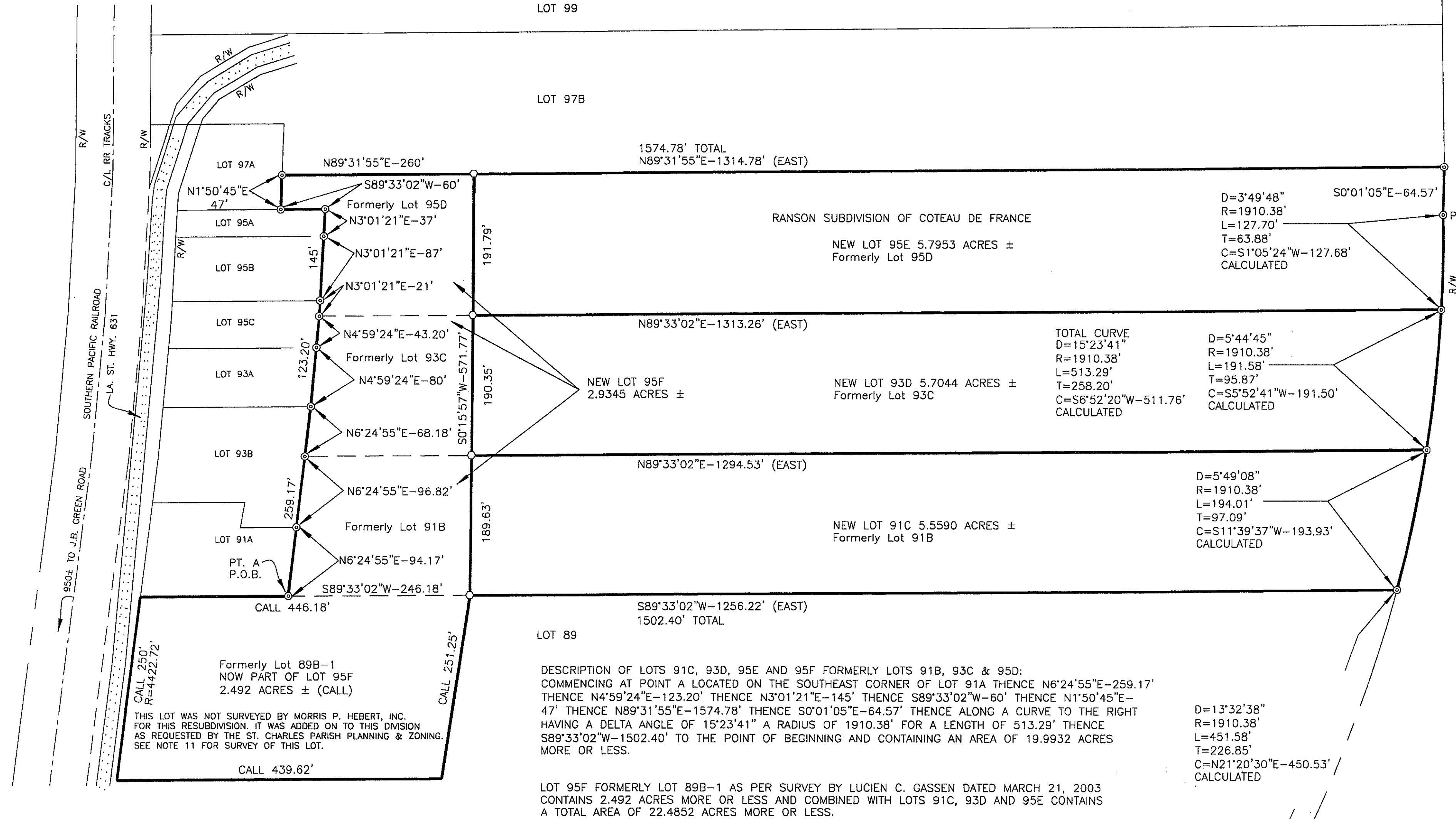
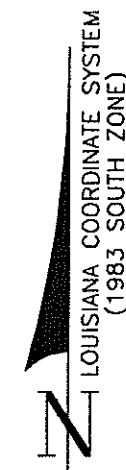

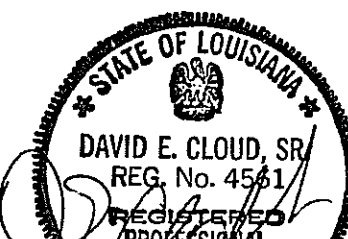

ALL PROPERTY CORNERS WERE SET WITH 3/4" IRON RODS EXCEPT AS NOTED.

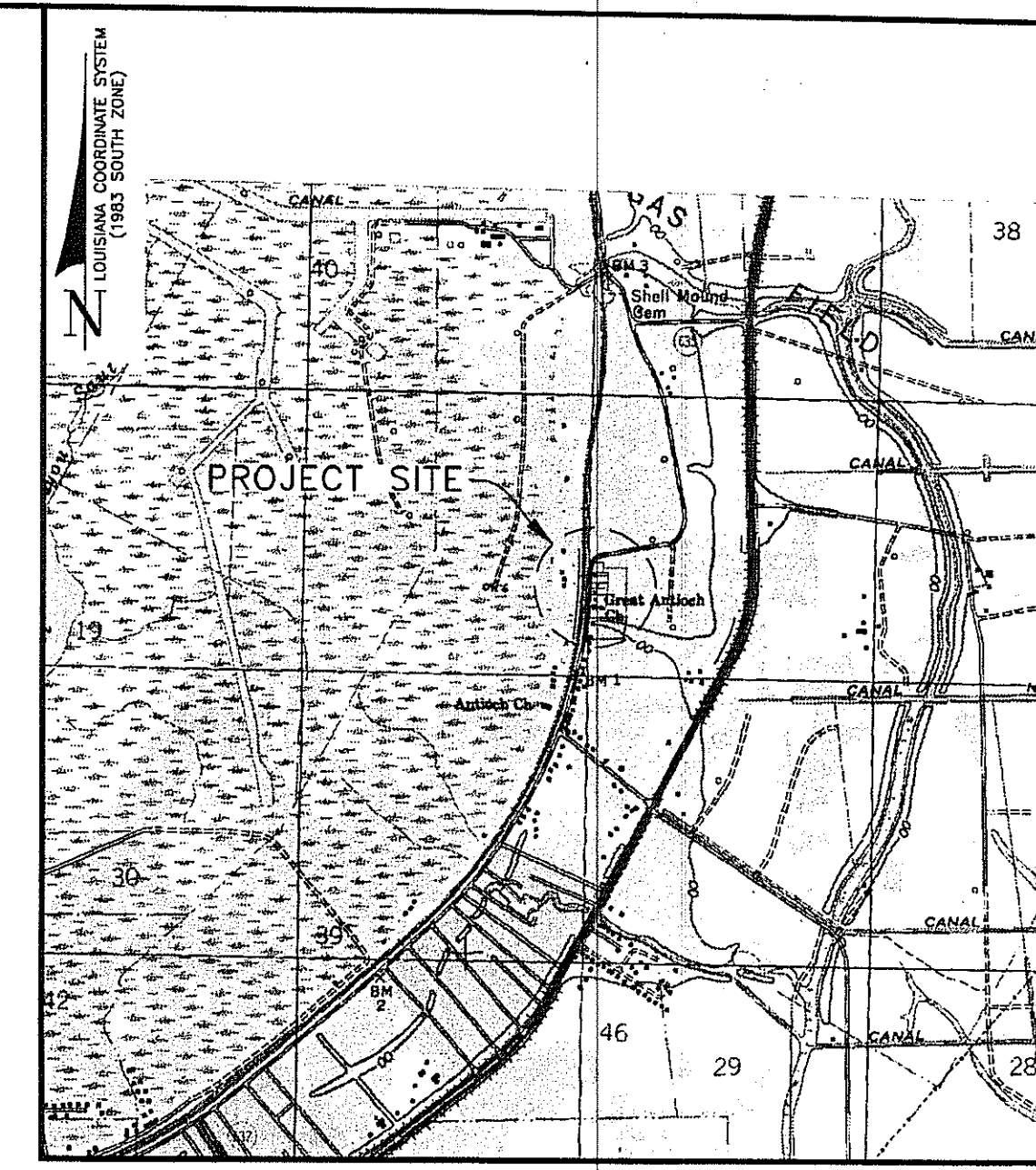
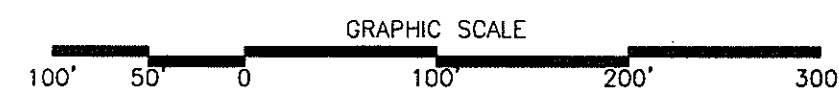
