ORDINANCE NO. 99-10-11

An ordinance to amend Ordinance No. 97-8-3, an Intergovernmental Agreement with Lafourche Basin Levee District, to provide additional funding of the West Bank Hurricane Protection Levee.

WHEREAS, the St. Charles Parish Council adopted Ordinance No. 97-8-3 on August 5, 1997 approving an Intergovernmental Agreement with the Lafourche Basin Levee District for continued funding of the West Bank Hurricane Protection Levee; and,

WHEREAS, the actual expenses covered under this agreement have exceeded the maximum of \$400,000.00; and,

WHEREAS, it is the desire of the District and the Parish to amend said agreement to cover the actual expenses.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That Amendment No. 1 to the Intergovernmental Agreement, State of Louisiana, Parish of St. Charles, by and between St. Charles Parish and the Lafourche Basin Levee District is hereby approved.

SECTION II. That the Parish President is hereby authorized to execute said Amendment No. 1 on behalf of St. Charles Parish.

PERSONALLY CAME AND APPEARED:

THE LAFOURCHE BASIN LEVEE DISTRICT, herein represented by Aubrey Gravois, its President, 21380 Highway 20, P. O. Box 670, Vacherie, Louisiana 70090

who hereby agree that the Intergovernmental Agreement dated August 17, 1997 is amended as follows:

ST. CHARLES PARISH: number 3 to read:

3. Shall invoice the Lafourche Basin Levee District for reimbursement of all expenses incurred in said project, up to the maximum of \$524,399.37.

THE LAFOURCHE BASIN LEVEE DISTRICT: number 1 and 2 to read:

1. Hereby agrees to allocate \$524,399.37 to the West bank Hurricane Protection Levee for the purpose stated.
2. Shall reimburse St. Charles Parish for all expenses incurred in said project, up to a maximum of \$524,399.37, upon being invoiced by St. Charles Parish.

All other provisions of the Agreement shall remain as first written.
