An ordinance to approve and authorize the execution of a contract with Volute, Inc. for Parish Project No. S190901 Destrehan Wastewater Treatment Plant (UV Replacement), with a Bid in the amount of \$342,887.00.

WHEREAS, sealed bids were received by St. Charles Parish on June 9, 2020, for Parish Project No. S190901 Destrehan Wastewater Treatment Plant (UV Replacement); and,

WHEREAS, AIMS Group, Inc. Consulting Engineers for the Project, have reviewed the bids and recommend that the Bid be awarded to the low bidder, Volute, Inc. in the total amount of \$342,887.00.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the bid of Volute, Inc. for the construction of St. Charles Parish Project No. S190901 Destrehan Wastewater Treatment Plant (UV Replacement), is hereby approved and accepted, in the amount of \$342,887.00.

PLEASE TAKE NOTICE that by virtue of a written contract dated August 12, 2020, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Chief Administrative Officer Mike Palamone on behalf of Parish President, Matthew Jewell, duly authorized by Ordinance No. 20-7-17, adopted by the St. Charles Parish Council on July 27, 2020, and Volute, Inc., 313 Venture Boulevard, Houma, LA 70360, through Dale C. Thompson, Jr., President, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Project No. S190901, Destrehan Wastewater Treatment Plant (UV Replacement), in St. Charles Parish, Louisiana for the price and sum of THREE HUNDRED, FORTY-TWO THOUSAND, EIGHT HUNDRED EIGHTY-SEVEN DOLLARS AND 00/100 (\$342,887.00). The work under the Contract to be completed within one hundred eighty (180) calendar days from the date of the Notice to Proceed.

Said basic work consists of installing a new UV disinfection system, which will be supplied by St. Charles Parish. The existing UV disinfection system and ancillary equipment will be removed and replaced with new UV disinfection system and ancillary equipment. Modifications to the UV disinfection structure will include installation of a new aluminum awning with lighting, modifications of existing concrete weir in the UV channel, installation of concrete baffle in the UV channel, and other modifications to allow for the proper installation of the new UV equipment, according to the Contract Documents prepared by AIMS Group, Inc. Consulting Engineers, dated and certified July 24, 2020 and signed July 30, 2020.

The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

Principal Work Location is the Destrehan Wastewater Treatment Plant in Destrehan, in St. Charles Parish, Louisiana. The treatment plant can be accessed via Jonathan Street from River Road to the north. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
