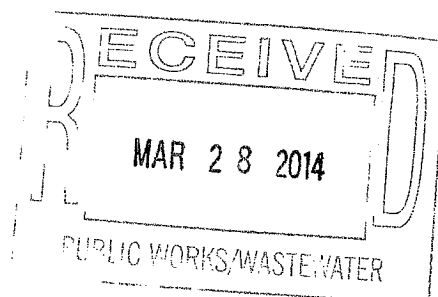
Please advise if stop signs can be installed at this location.
