ADDITION TO J.B. GREEN RECREATION SITE

Please find the attached proposed ordinance and Act of Sale for your review and comments.

The following is some background information and questions that need answering by the Parish Council and the Parks and Recreation Department.

The Parish purchased Lot 73-b as shown on the attached drawing for use as a recreation park on J.B. Green Road in Des Allemands. The usefulness of the site as a ballpark for which it was purchased is limited due to the depth and irregular shape of the purchased lot as stated by the previous Recreation Director.

Since the purchase, the adjacent property has been resubdivided creating a 100' wide lot labeled Lot 9 as shown on the attached drawing. The acquisition of this lot would increase the depth of the park making the site more useable since the property deepens toward the north. Attached is another scaled drawing showing Lot 9 adjacent to the existing Lot 73-b which shows how the park would deepen. This site is available now but will not be in the future after it is sold to others.

Attached are calculations showing the cost for Lot 73-b and the proposed cost for Lot 9. Lot 73-b was sold at a price below market value. Mr. L.J. Frickey has offered this site at the price per square foot which he claimed he has sold some of the other lots for. Combining the two sales would result in the equivalent purchase price of \$1.08 for the entire site which is a low overall cost.

With the increase in width that would result, the Parish could create a 100' wide lot on the southern side of Lot 73-b and put it up for sale if it is not really needed. This would allow the Parish to recoup some of the expense to purchase Lot 9.

By this memo, I am asking that Mr. Duane Foret, Parks and Recreation Director, provide his input in the form of a memo back to the Parish Council as to: 1) whether or not this purchase would make the site better suited for a ballpark, and 2) would the elimination of the southern 100' of the site for sale as a lot hurt the usefulness of the site?

The question for the Parish Council is whether or not it feels that the cost at \$2.75/sf is reasonable or not? It is definitely reasonable when looking at the equivalent price of \$1.08 that the Parish will have paid for the entire site if it purchases this lot.

Please provide comments back to me by March 14, 2008.

Vendees accepts the above described properties subject to the restriction referred to herein and agree for themselves, their successors and assigns to be boun thereby.




All parties hereby agree to waive the production of tax and mortgage certificate and hereby relieve and release me, Notary, for any liability regarding their not production.


