

NOTICE OF CONTRACT

PLEASE TAKE NOTICE that by virtue of a written contract dated December 7, 2017, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Larry Cochran, duly authorized by Ordinance No. 17-11-12, adopted by the St. Charles Parish Council on November 27, 2017, and Barriere Construction Co., L.L.C., 1268 LA 3127, Post Office Box 1576, Boutte, LA 70039, through Daniel C. Donahoe, Group Manager, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Road Maintenance 2017, Parish Project No. 160302-4; the repair and improvements of existing asphalt streets in St. Charles Parish, Louisiana, including milling and overlay of asphalt, pavement patching, restoration of streets, placement of shoulder material, and all incidental services thereto for the price and sum of ONE MILLION NINETY- THOUSAND SIX HUNDRED TWENTY-TWO AND 50/100 (\$1,090,622.50) DOLLARS. The work under the Contract to be completed within Ninety (90) calendar days from the date of the Notice to Proceed. Said basic work to include the construction of all improvements as shown on the Drawings, Specifications and Contract Documents for Parish Project No. P160302-4, Road Maintenance 2017 with Base Bid and Alternate No. 1, as prepared by Barowka and Bonura Engineers and Consultants, LLC, dated November 30, 2017. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is generally described as those public rights-of-way on the East and West Banks of St. Charles Parish, as per the detailed plans and specifications prepared by Barowka and Bonura Engineers and Consultants, LLC.
