Saint Charles Parish – 2014 Road Maintenance Program

On Monday, 2/2/2015, the final inspection of the 2014 Road Maintenance Program was performed. The following individuals were in attendance:

- Gavin Gillen GEC Project Manager
- Frank Wiley GEC Inspector
- Lee Zeringue SCP DPW Engineer
- Jordan Dejean SCP DPW Inspector
- Gene Pepper Barriere Project Manager

The following is a "punch list" of work that must be performed prior to final acceptance of the project, followed by the estimated cost of each item in parenthesis:

- All roadways in the program must open each manhole cover to make sure the Parish will have access to the manholes. (\$500)
- The pipe on West Pine (close to Pine St.) must be filled in with concrete. (\$1,400)
- Drop inlets at the following addresses need asphalt aprons along Spruce St.: 436, drop inlet north of 436, 464, and 470. (\$800)
- There is a yellow-green construction cone on West Pine near the pipe that needs to be filled. (\$50)
- Project signs need to be taken down. (\$200)
- Add earthen shoulder material along the recently widened sections of St. John. (\$550)
- Clean-up the cracked asphalt section in front of 236 Lorraine. (Saw-cutting along the original edge of the roadway and removing the crumbling asphalt was the plan to address this issue). (\$100)
- Per the owner of the cracked driveway apron on Lorraine, he does not care if the apron is fixed. (\$0)
- Fix the driveway on Cynthia St. (\$250)
- Fix the cracked driveway on Carlon St. (\$250)
- Add mix as an apron to the shell driveway at the intersection of Dejean and Highway 631 (Old US 90). (\$200)
- Striping for Oak Lane, Spruce, and Pine is needed. (\$5,100)
- Fire Hydrant buttons must be placed throughout the entire project. (\$550)
- Add asphalt to the driveway of 314 Amelia to remove the lip. (\$500)

Upon receiving this document, the contractor will have 60 days to address all "punch list" items.
