An ordinance to amend Ordinance No. 02-4-3, an Agreement between the Center for Family and Youth Services, Inc. and St. Charles Parish to implement Louisiana Commission on Law Enforcement and Administration of Criminal Justice Subgrant Number A00-8-002 to increase the Grant amount from \$102,594.00 to \$107,594.00.
