OWNER: St. Charles Parish will assume insurance upon final payment. No warranties or guarantees will be assumed by St. Charles Parish until the one-year warranty/guarantee period has ended, in full accordance with Article 13.12 of Section 00700 of the Bayou Gauche Walking Track Contract Documents.



Contractor shall maintain all warranties and guarantees for a period of one year after the substantial completion date, in full accordance with Article 14.8 of Section 00700 of the Bayou Gauche Walking Track Contract Documents.




