

THE FOLLOWING IS A LIST OF ITEMS TO BE ADDRESSED. THESE ITEMS WERE NOTED DURING JOBSITE INSPECTION ON MAY 10, 2017. ITEMS WERE DISCUSSED IN THE FIELD AND INDICATED TO THOSE PRESENT WITH AGREEMENT.

- 1) Spot-paint sheets, cap, welds, and walers as necessary. Value: \$1,000.00.
- 2) Install waler on sheet pile cutoff at obstruction location. Value: \$1,800.00.
- 3) Form and pour concrete swale at Linwood. Value: \$3,704.00.
- 4) Reset metal guardrail at Linwood Gate. Value: \$500.00.
- 5) Re-dress excavated area in front of wingwall with clay and riprap. Value: \$1,500.00.
- 6) Dress up levee top, berm, and toe; restore levee to original condition and elevation, including seeding. Value: \$2,500.00.
- 7) Finish installing rock under three 18" pipe drain penetrations. Value: \$500.00
- 8) Repair several locations of fences that were damaged by Contractor's equipment (142 Dunleith, 2" metal pipe corner post; Sta. 147+00, 4x4 wooden post in concrete; corner of Linwood Drive; and any others pointed out by our inspector). Value: \$500.00.
- 9) Walk through levee and backfilled area, remove all loose debris (wood, metal, rocks, and concrete, etc.). Value: \$500.00.

- 10) Clay topsoil per specifications. Value: \$17,136.00.
- 11) Sod and seeding per specifications. Value: \$9,965.34.
- 12) Restore Linwood Drive Crossing and clean entrance and exit from project site on Linwood Drive. Value: \$1,000.00.
- 13) Check all culvert penetrations through the sheet pile wall and seal as necessary.

 Value: \$500.00.
- Demobilize equipment, remove containers, barges, etc. Value: \$0 (per Contract,100% may be invoiced at Substantial Completion).
- 15) Supply red-line drawings and post-construction survey. Value: \$1,500.00.
- 16) Remove project sign. Value: \$500.00.
