Dear St. Charles Parish Council,

I am writing in regards to the way the Public Hearing was deemed satisfied for the 2005 Budget on Tuesday, October 19, 2004.

If the budget had been voted on that night, I could have understood. But as you know the budget was tabled, to be brought up at the November 1, 2004 Council meeting. There was to be a Public Hearing before the vote. Since there is more discussion and possible amendments or changes to the budget, the Public Hearing should not have been satisfied.

It seems to me that this was a clear cut case to keep the concerned citizens, who usually attend the Council meetings, from participating in the Public Hearing. I know that there were three meetings held for the budget with Public Hearings. But, one was an all day affair making it hard for people who worked to attend. The other two lasted only an hour or so, starting at a time most people are just getting home from work. There was no set agenda as to what department budgets would be brought up, discussed and voted on.

Since the ordinance for the budget has not been voted on, I request that the Public Hearing be re-opened before the vote is taken on the adoption of the budget. That would be the right thing to do. Remember, Council members are elected to represent and serve the people of this parish, not the administration.

I would appreciate if this letter could read aloud at the November 1, 2004 Council meeting, or at least before the vote on the budget is taken.
