ORDINANCE NO. 07-4-9

An ordinance to approve and authorize the execution of Amendment No. 8 between the Center for Family and Youth Services, Inc. and St. Charles Parish to implement Louisiana Commission on Law Enforcement and Administration of Criminal Justice Subgrant Number A05-8-002.

- WHEREAS, St. Charles Parish, in conjunction with the Judges of the 29<sup>th</sup> Judicial District, the Sheriff's Office, District Attorney's Office and the Schools Drug Free Program applied for a Juvenile Accountability Incentive Block Grant through the Louisiana Commission on Law Enforcement and Administration of Criminal Justice to develop and administer accountability based sanctions for juvenile offenders; and,
- WHEREAS, the Parish was notified that the Commission has revised the Grant in the amount of \$25,000.00 Federal Funds with a local cash match of \$10,600.00 for a total of \$35,600.00 for the contract period of October 1, 2006 to September 30, 2007; and,
- WHEREAS, the application designated the Center for Family and Youth Services, Inc. as the implementing agency for the Grant; and,
- WHEREAS, it is the desire of the Parish and the Center for Family and Youth Services to enter into an agreement for the implementation of Subgrant Number A05-8-002

## THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

**SECTION I.** That Amendment No. 8 to the Agreement between the Center for Family and Youth Services, Inc. and St. Charles Parish is hereby approved.

**SECTION II.** That the Parish President is hereby authorized to execute said Amendment on behalf of St. Charles Parish.

## Amendment No. 8 Agreement Between The Center For Family and Youth Services, Inc. and St. Charles Parish

BE IT KNOWN that on this 23 R day of April , 2007, The Center for Family and Youth Services, Inc., 13101 River Road, Luling, Louisiana 70070, herein represented by Alton James, President, acting pursuant to a Resolution of its Board of Directors adopted on 14-23-07, and St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, herein represented by Albert D. Laque, Parish President, acting pursuant to Ordinance No. \_\_07-4-9 adopted by the St. Charles Parish Council on <u>04-16-07</u>, agree that the agreement be amended as follows:

## St. Charles Parish shall:
