ORDINANCE NO. 03-10-13

An ordinance to approve and authorize the execution of an Act of Donation and Quitclaim Deed by The Mitchell Company, Inc. and Ormond Country Club Estates Homeowners Association, Inc. to St. Charles Parish for recreational requirements of Ormond Country Club Estates, Section 12, Phase D-2.

WHEREAS, The Mitchell Company, Inc. has completed development of Phase D-2 of Section 12 in Ormand Country Club Estates; and,

WHEREAS, it is the desire of The Mitchell Company, Inc. to donate land to meet the Recreational requirements with the donation of the existing recreational area located at the corner of Nottaway Drive and Longview Drive; and,

WHEREAS, The Mitchell Company, Inc. had established the Ormond Country Club Estates Homeowners Association, Inc. and the property being donated herein was transferred to the Homeowners Association which was never active; and,

WHEREAS, it is the desire of the Parish Council to accept the Act of Donation and Quitclaim Deed by The Mitchell Company, Inc. and Ormond Country Club Estates Homeowners Association, Inc. to satisfy the recreational requirement for Phase D-2, Section 12, Ormond Country Club Estates.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the Act of Donation and Quitclaim Deed by The Mitchell Company, Inc. and Ormond Country Club Estates Homeowners Association, Inc. is hereby approved.

SECTION II. That the Parish President is hereby authorized to execute said Donation on behalf of St. Charles Parish.

and subrogation, all rights Donors have herein and do by this formal Act of Donation and Quitclaim irrevocably give, donate, quitclaim and deliver unto:

all of their right, title and interest which Donors have or may have in and to the following described property:

ONE CERTAIN PIECE OR PORTION OF GROUND, together with all the buildings and improvements thereon, and all the rights, ways, privileges, servitudes, advantages and appurtenances thereunto belonging or in anywise appertaining, situated in Section 14, T 12 S, R 8 E, and Section 3, T 13 S, R 8 E, ORMOND COUNTRY CLUB ESTATES, SECTION 12, St. Charles Parish, Louisiana, forming a portion of former Parcel 10A-2-A, all located and measuring as per plan of resubdivision made by J. J. Krebs & Sons, Inc., Job No. 4920041, dated January 25, 1994, revised July 13, 1994, registered in the Conveyance Records of St. Charles Parish in COB 488, folio 763, and being a portion of Parcel 11 and described as follows:

Commencing at the northwesterly most point of Parcel 11, which point is the point of beginning; thence running along a line South 30 degrees, 0 minutes, 24 seconds East, a distance of 65 feet to a point; thence running along a line South 59 degrees, 59 minutes, 36 seconds West, a distance of 105 feet to a point; thence running along a line fronting on proposed Nottaway Drive North 30 degrees, 0 minutes, 24 seconds West, a distance of 53.62 feet to a point; thence along a curve having a radius of 20 feet, a distance of 33.46 feet to a point; thence running along a line fronting on Longview Drive North 65 degrees, 51 minutes, 24 seconds East, a distance of 83.39 feet to the point of beginning.

This donation is made and accepted subject to the following:

- 1. All servitudes and restrictions of record;
- 2. The sewer lift station servitude located in the northwesterly part of the portion of ground; and
- 3. The five foot servitude running along Longview Drive.

Being the same property acquired by Donor herein by Act of Sale before Shirley H. Kirkes, Notary Public, dated October 1, 1993, registered in COB 471, folio 274, Instrument No. 178269, of the conveyance records of St. Charles Parish, Louisiana.

Further, pursuant to that certain plan of resubdivision of J. J. Krebs & Sons, Inc., dated September 9, 1996, approved by the St. Charles Parish Council on November 4, 1996, under Ordinance No. 96-11-1, said lot of ground is designated as Lot 224, in Square C of Ormond

Country Club Estates, Section 12, Phase D-1. (hereinafter the "Property").

TO HAVE AND TO HOLD the property unto Donee, its heirs, successors and assigns forever.

AND NOW INTO THESE PRESENTS COMES DONEE, who hereby acknowledges receipt of the said donation of said property with gratitude and appreciation.

Further, no title examination has been performed whatsoever and the parties release us, Notaries, from any liability.
