Interested parties are hereby notified that the Coastal Management Division of the Department of Natural Resources has received the following application for a Coastal Use Permit (CUP) in accordance with the State and Local Resources Management Act of 1978, as amended, (Louisiana R.S.49, Sections 214.21-214.41), and the rules and regulation of the Coastal Resources Program.

Application has also been made to the Louisiana Department of Environmental Quality, Office of Environmental Services for a Water Quality Certification in accordance with statutory authority contained in the Louisiana Revised Statutes of 1950, Title 30, Chapter 11, Part IV, Section 2074 A(3) and provisions of Section 401 of the Clean Water Act (P.L. 95-217).

**LOCATION:** ST. CHARLES, LA: POB at Lat. 29°58'54"N, Long. 90°28'03"W and POE at Lat. 29°59'20"N.

Long. 90°27'41"W; Secs. 50 and 51, T13S-R20E and Secs. 24, T12S-R20W; near Waterford, LA.

**DESCRIPTION:** 

Proposal to install ±4,188' of one (1) 12" natural gas pipeline and one (1) fiber optic cable. Approximately 950 cu. yds. of material will be excavated from an 8' wide trench. The spoil material will be stockpiled adjacent to the trench and used as backfill upon successful completion of the project. Approx. 1.9 acres of wetlands and 5.7 acres of upland developed habitat may be impacted as a result of this activity\*. Of the 1.9 acres of wetland impacts.

0.15 acres will occur within the Louisiana Coastal Zone (below the 5' contour).

The official date of the beginning of the public comment period for Coastal Use Permits and Water Quality Certification applications begins on the date of publication of the notice in the official state journal (The Advocate), in accordance with the Rules and Procedures for Coastal Use Permits, §723.C 5.c The Coastal Management Division will inform interested parties of the exact date of publication on request.

\*Habitat impacts are based on available in-house data and may not represent actual conditions. Field reconnaissance may be required to verify extent of impacts.

THE APPLICANT MUST SECURE A STATE COASTAL USE PERMIT. LOUISIANA DEPARTMENT OF ENVIRONMENTAL QUALITY WATER QUALITY CERTIFICATION IS ALSO REQUIRED. INDEPENDENT EVALUATIONS AND DECISIONS WILL BE MADE BY THE COASTAL MANAGEMENT DIVISION AND THE DEPARTMENT OF ENVIRONMENTAL QUALITY.

Comments concerning this application can be filed with the Office of Environmental Services within ten days of this notice to the following address: Louisiana Department of Environmental Quality, Office of Environmental Services, P.O. Box 82135, Baton Rouge, Louisiana 70884. All comment letters should contain both the applicant's name and the appropriate application number.

## State of Louisiana Coastal Use Permit Criteria

The decision on whether or not to issue a Coastal Use Permit will be based on an evaluation of the probable impacts of the proposed activity in accordance with the state policies outlined in R.S. 49:214.22. The decision will reflect the national concern for both protection and utilization of important resources. The decision must be consistent with the state program and approved local programs for affected parishes and must represent an appropriate balancing of social, environmental and economic factors. All factors which may be relevant to the proposal will be considered; among these are flood and storm hazards, water quality, water supply, feasible alternative sites, drainage patterns, historical sites, economics, public and private benefits, coastal water dependency, impacts on natural features, compatibility with the natural and cultural setting and the extent of long term benefits or adverse impacts.

## State of Louisiana Water Quality Certification Criteria

In accordance with the Joint Public Notice Agreement between Coastal Management Division and the Office of Water Resources, notice is hereby given that the applicant has applied to the Louisiana Department of Environmental Quality, Office of Environmental Services for a Water Quality Certification in accordance with statutory authority contained in the Louisiana Revised Statutes of 1950, Title 30, Chapter 11, Part IV, Section 2074 A(3) and provision of Section 401 of the Clean Water Act (P.L. 95-217).


