An Ordinance to create the Department of Community Services; to provide for its functions and responsibilities; and provide for the duties of its Director.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

WHEREAS: The Parish now provides funding for various community

service agencies; and,

WHEREAS: The functions of some agencies do overlap; and,

WHEREAS: It is in the best interest of the Parish to have a

special department to direct, govern, manage and

supervise certain parish agencies; and,

It is in the best interest of the Parish to have a WHEREAS:

special department to serve as liaison between St. Charles Parish and other parish community agencies.

BE IT ORDAINED BY THE ST. CHARLES PARISH COUNCIL THAT THERE IS HEREBY CREATED THE DEPARTMENT OF COMMUNITY SERVICES; AND

BE IT ORDAINED THAT THE FUNCTIONS AND RESPONSIBILITIES OF THE DEPARTMENT SHALL INCLUDE BUT NOT BE LIMITED TO THE FOLLOWING:

- The administration and supervision of Community Action, Food Stamp and the Emergency Assistance Programs to serve St. Charles Parish from the date of this Ordinance forward.
- Establish and maintain a working relationship with the following agencies and to monitor their activities:

Council On Aging Health Unit River Parishes Council of Government Welfare Department St. Charles Housing Authority Library Drivers License Coroner Mental Health Registrar of Voters Veteran Services

...and all other community services organizations within the Parish.

BE IT ORDAINED THAT THE DIRECTOR OF COMMUNITY SERVICES SHALL BE APPOINTED BY THE PARISH PRESIDENT AS STATED IN ARTICLE III, SECTION C.1.b. OF THE HOME RULE CHARTER, AND THE DIRECTOR'S DUTIES SHALL CONSIST OF CARRYING OUT THE FUNCTIONS AND RESPONSIBILITIES OF THE DEPARTMENT OF COMMUNITY SERVICES.
