ORDINANCE NO. 01-9-4

An ordinance to approve and authorize the execution of an amendment to the Contract for Engineering Services with Shread-Kuyrkendall & Associates, Inc. for necessary professional engineering services associated with Project Representation for Subdivision Construction, Project No. P000301.

WHEREAS, the St. Charles Parish Council desires to have the following described project undertaken:

**PROJECT DESCRIPTION:**

Engineering services for Project Representation for Subdivision Construction. The services will include providing project representative services for construction of all major subdivisions within the parish; and,

WHEREAS, on April 25, 2000 the St. Charles Parish Qualifications Based Selection Review selected the firm of Shread-Kuyrkendall & Associates, Inc. to provide engineering services for said project; and,

WHEREAS, on June 5, 2000, the St. Charles Parish Council passed Ordinance 00-6-2 which authorized the execution of a Contract for Engineering Services with Shread-Kuyrkendall & Associates, Inc. for necessary professional engineering services associated with project representation for subdivision construction, Project No. P000301; and,

WHEREAS, it is the desire of the St. Charles Parish Council to extend the term of this contract for an additional year in accordance with Paragraph 5.1 of said contract.

**THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:**

**SECTION I.** That the Contract for Engineering Services between Shread-Kuyrkendall & Associates, Inc. and the Parish of St. Charles is hereby amended.

**SECTION II.** That the Parish President is hereby authorized to execute said amendment on behalf of the Parish of St. Charles.
