

00050 - AGREEMENT SECTION

THIS AGREEMENT, made this 30th day of August 2001, by and between the St. Charles Parish Council (hereinafter called "Owner") and Civil Construction Contractors, Inc. doing business as a corporation, (hereinafter called "Contractor").

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

1. The Contractor will commence and complete the construction of

The West Bank Bridge Park Walkway Expansion Project, Bid Items 1 and 2, complete including a concrete perimeter walkway. Associated construction includes subsurface drainage near the outfalls, swale construction and earthwork, and seeding and fertilizing as shown on the project plans and specifications.

2. The Contractor will furnish all of the material, supplies, tools, equipment, labor and other services necessary for his construction and completion of the project described herein.

3. The Contractor will commence the work required by the Contract Documents on the date specified in the Notice To Proceed and will complete the same within 90 calendar days thereafter unless the period for completion is extended otherwise by the Contract Documents.

4. The Contractor agrees to perform all of the Work described in the Contract Documents for the sum of Eighty Six Thousand Six Hundred Twenty Seven Dollars and Zero Cents (\$ 86,627.00), payable in current funds, subject to additions and deductions, if any, as provided in the Contract Documents.
