ORDINANCE NO. <u>04-12-6</u>

An Ordinance to amend the 2004 Consolidated Operating and Capital Budget to adjust Beginning Fund Balances to Actuals and to adjust Revenues and Expenditures in various funds.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

WHEREAS, the 2004 St. Charles Parish Consolidated Operating and Capital Budget was adopted by Ordinance No. 03-11-4 on November 6, 2003; and amended April 19, 2004 by Ordinance No. 04-4-19; April 2, 2004 by Executive Order 04-1; August 16, 2004 by Ordinance No. 04-8-17; August 9, 2004 by Executive Order 04-2; October 15, 2004 by Executive Orders 04-3 thru 04-8; and October 20, 2004 by Executive Order 04-9; and

WHEREAS, the Council has taken under consideration the study of the amendment to the St. Charles Parish Consolidated Operating and Capital Budget for fiscal year 2004 as shown by the Revision Schedule; and,

NOW, THEREFORE, in accordance with the provisions of Article V, Sections D, E, and F of the St. Charles Parish Home Rule Charter and with the Louisiana Local Government Budget Act (R.S. 39:1301 et. seq.), the St. Charles Parish Council does hereby ordain to adopt the 2004 St. Charles Parish Consolidated Operating and Capital Budget as amended, and that it be attached hereto and made a part hereof and identified as "Exhibit A".
