

As I spoke with you on March 9<sup>th</sup> 2013 @ 12:45PM, we are willing to work with owner of the Wheel house electronics and the resident behind him and we are willing to give 2.5' for servitude to make 5' drainage servitude for drainage to the highway 90 when we construct business. We already have made the rough drainage; slopes towards highway 90 on my side of the property.

But, the issue is that the water is not draining fast enough on highway 90 drainage system. From McDonalds in Paradis, the drain water is held back and comes to A-1 Motel parking lot. This was before the vacant ground was filled with dirt because water was staying in the ground. Now the ground is filled with dirt and is leveled off, and slopes toward highway 90. More water will back up into A-1 Motel parking lot from drainage of highway 90. I think bigger underground drainage line required at McDonalds in Paradis.

There is no underground drainage line from Wheelhouse Electronics, 15227 highway 90 to the intersection of highway 90 & Wisner St., St. Charles Lighting 15223 highway 90 in Paradis. Their driveways are solid ground.

The residents' on115 Red Gros Ln, & 150 Travis Street, in Paradis, complaint at hearing was that the water is not draining from their yard. They want to resolve their issues. However, the slope of 115 Red Gros property towards McDonalds' concrete fence; allows water to enter their backyard or ground sunk because of weight of above ground swimming pool water. I think the slope should be the other way around towards Red Gros Lane.




