Punch list items:

- 1) Dress up around each cross over, paying close attention to adding clay material in each corner and around the cross overs. \$3,000.00
- 2) Dress up alongside the edge of the roadway, bringing the level of fill material even with the height of the roadway filling in all gaps or voids. \$6,000.00
- 3) Pick up construction materials and other debris. \$500.00
- 4) Clean up around opening of each RCP and around rip rap. \$2,000.00
- 3) Hydro-seed a 5' width along the perimeter of the roadway and around each crossover. \$3,500.00
