ORDINANCE NO. 09~7–15

An ordinance to approve and authorize the execution of a Cash Sale of Parcel S-1 of the Matthews/Oliviera Lands, Paradis, St. Charles Parish, Louisiana, from Paradis Plantation, LLC for the Paradis Pump Station.

- WHEREAS, the Parish Council adopted ordinance 07-3-12 on March 19, 2007 authorizing a contract with Buchart Horh, Inc to provide engineering and construction services for the installation of project P070107 Paradis Pump Station Bar Screen Cleaner and Deck; and,
- WHEREAS, Buchart Horn has completed the design and obtained necessary permits, and a FEMA Grant in the amount of \$750,000 has been granted: and.
- WHEREAS, the purchase of an area of 0.1449 acres adjacent to the pump station is required to allow equipment access to perform station maintenance and deck cleaning by Public Works personnel; and,
- WHEREAS, it is important that St. Charles Parish proceed with this project in order to protect the property and well being of its citizens; and,
- WHEREAS, Paradis Plantation LLC has agreed to sell the property as described in the attached Cash Sale for the sum of \$11,986.50.


