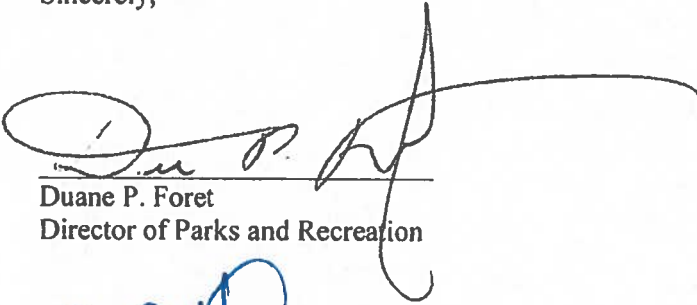
The Supplemental Instructions to Bidders, St. Charles Parish Specification Section SCP-E-00101, states the following regarding Bid Security, "The Bid Security of any Bidder whom Owner believes to have a reasonable chance of receiving the award may be retained by Owner until the forty-six (46th) day after the bid opening." The section also states, "The Owner and the Lowest Responsible Bidder may mutually agree in writing to extend the deadline for award by one or more extensions of thirty (30) calendar days, as provided in La. R.S. 38:2215 (A)."

The bid opening for the above-mentioned project was held on Thursday, May 7, 2026, and therefore the forty-sixth (46th) day after the bid opening will be Monday, June 22, 2026. The construction contract will be introduced to the St. Charles Parish Council on Monday, June 15, 2026, and will be brought in front of the Council for acceptance on Monday, July 13, 2026. Based on these dates, St. Charles Parish is requesting an extension of the deadline for award by thirty (30) calendar days. This extension would bring the deadline to Wednesday, July 22, 2026. This request is subject to TEH Enterprise, LLC honoring their bid of One Million Four Hundred Thirty Thousand Dollars (\$1,430,000.00). This bid price includes the Base Bid plus Alternate No. 1.

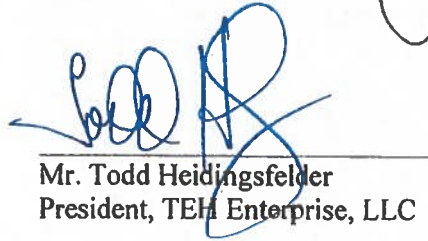
