RESOLUTION NO. 5872

A resolution requesting the assistance and support of the Louisiana Department of Transportation and Development in the priority construction projects of St. Charles Parish.

WHEREAS, the Parish Council firmly believes the following listed issues are priority projects, which will benefit all of the citizens of St. Charles Parish:

- **Relocation of LA 3060 (Barton Avenue) to a new State route from US 90 to LA 18 at Willowdale Boulevard**
- **Construct Center Turn Lane on US 90 from Maryland Drive to Coronado Drive West and Reduce Speed Limit**
- **Construct a Center Turn Lane on US 90 through Paradis**
- **Construct a Center Turn Lane on LA 48 from Ormond Plantation to I-310**
- **Construct a Flyover Ramp for eastbound Highway 90 traffic to access I-310 northbound**
- **Install Traffic Control Signal at the intersection of LA 626 and US 61**

WHEREAS, the Parish Council is requesting that the Department of Transportation and Development work with St. Charles Parish in accomplishing these projects.
