# TOTAL SHELTER INTAKE



- Dogs 531 (1% increase from 2020)
- 2019 688
- Cats 875 (2% increase from 2020)
- 2019 1227

#### **HOW THEY FIND HOMES**

- Reclaimed by OWNER
- Cats 20 (10%)-2019 3% (1% decrease)
- Dogs 115 (22%)-2019 29% (7% decrease)
- Adopted LOCALLY
- Cats 85 (55% decrease from 2020)
- Dogs 69 (16% decrease from 2020)
- Adopted NATIONALLY
- Cats 149 (6% increase)
- Dogs 166 (3.75% increase)





## LIVE OUTCOME


Dogs 82% Live Release Rate (2020 87% LRS)

Cats: 68% Live Release Rate (2020 79% LRS)


# Length of Stay 2021

- **Dogs** 20.7 days (2020: 8.7 days, max 141d)
- (2019 15d, max 215d=58 % decrease in LOS, 65% decrease in max LOS)
- Cats 13.9 days (2020: 9.6 days, max 150 days)
- (2019 19d, max 190d=51% decrease in LOS, 79% decrease in max LOS)

# Dangerous Spectrum

- In past 2 years: 83 dogs on dangerous spectrum due to bite to human or pet
- 48% were bully type
- 10% of dogs deemed, reoffended and moved up on spectrum
- 90% of owners, responsibly contained their pets to keep from reoffending

# NEW OPTIONS ↑ FOSTERING

- Mobile Medical: new options since 2020 to assist residents without grouping pets or people while maximizing resources.
- Full medical care brought to the owner surrendering a pet. Surrendering owner keeps the pet in the home where they are comfortable and shelter staff place them in permanent homes within 2 weeks.
- Our community has this option

### GRANT OPPORTUNITIES

- Greater Good Charities: we participated in 20 jet flights (\$25,000 each). 29 dogs were heartworm +, thus saving the parish \$14,500 in medical expenses caring for dogs with mosquito transmitted heartworms. Also, donated heartworm prevention and flea/tick prevention for our entire shelter population for 2021.
- Petco and PetSmart \$10,000 in Ida pet recovery to support the community
- Department of Agriculture
- ASPCA \$75,000 grant to host emergency response training for shelters across Louisiana. We
  hosted a shelter directory symposium and EOC directors collaborated on emergency response for
  pets. Hosted radiological decontamination, ropes and rescue and animal sheltering in disasters.
- Turning Rescues Into Pets (TRIP) + GGC=\$5K in our community
- Department of Agriculture: \$10,000 in wire crates and \$10,000 in food donations for community.
   50 calls to service during Ida to support owned pets and provide opportunities for feeding in place vs impounding.

# Animal Municode Updates

- 4-6 Dangerous Dog Ordinance revised
- 4-51 Redemption and Adoption: 70% spay/neuter now for the lesser redemption fee, mandatory microchip to improve reuniting rate



# Network & Response

- Multiparish effort: Worked with our coastal parish shelters in transport year round and prior to disaster
- Hosted Code 3 Module B for training Animal Control Officers nationally in Humane Officer & Investigation




