An ordinance approving and authorizing the execution of a Professional Services Agreement with Linfield, Hunter & Junius, Inc., to perform engineering services for the New Sarpy CN Culvert Crossings (Project No. P250301), in the amount not to exceed \$692,052.00.

- WHEREAS, the Parish desires to improve drainage in the New Sarpy area by installing additional culverts under the Canadian National Railway (CN) at Troxclair Canal and Vans Lane, as well as installing a new culvert underneath Vans Lane immediately south of CN to replace an existing culvert; and,
- WHEREAS, the Parish has been awarded funding from the Resilient Communities Infrastructure Program (RCIP) for construction of this project; and,
- WHEREAS, the Professional Services Agreement between St. Charles Parish and Linfield, Hunter & Junius, Inc., described the details of the proposed services and compensation.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the Professional Services Agreement between St. Charles Parish and Linfield, Hunter & Junius, Inc., to perform engineering services as required by the Department of Public Works, for the New Sarpy CN Culvert Crossings (Project No. P250301) is hereby approved and accepted in the amount not to exceed \$692,052.00.

SECTION II. That the Parish President is hereby authorized to execute said Agreement on behalf of St. Charles Parish.
