PROPOSED ORDINANCE, FILE NO. 2008-0170

This proposed ordinance will be taken up for consideration at the April 7, 2008, Parish Council Meeting. This is a recap of the important information regarding this proposed purchase which I ask that you consider and take into account prior to casting your vote:

- 1. Lot 9 is currently available for increasing the usefulness of the site but will no longer be once it is sold for residential use.
- 2. The existing site has limited depth for a ball field. The property deepens toward the north and the purchase of Lot 9 would provide additional depth for the field (see the attached sketch).
- 3. A 100' wide portion of the southern end of the site can be eliminated with the purchase of the additional 100' wide Lot 9 on the northern end. This can be broken into two residential lots and sold in order to offset the purchase price for Lot 9.

The Parks and Recreation Department has stated that it does not feel that purchasing the property would enhance the park in such a way to warrant the \$72,667.00 expense. It is also the opinion of the Department that increasing the size of the site will not enhance the usefulness of the park and that the purchase to increase the depth of the site would not make it better suited for a ballpark. The Department does agree that the elimination of the southern 100' of the site would not hurt the park area in any way, shape, or form. Residence

- 1. The \$72,667.00 expense can be offset by the sale of the southern 100' of the site (sold as 2-50' wide residential lots) for a total cost of approximately \$52,000.00 (\$26,000.00 each). The purchase of Lot 9 would end up having a net cost of only \$20,667.00. The Recreation Department did not take this into account in its opinion.
- 2. Increasing the depth of the park can do nothing but help to increase the usefulness of the site as a ball field. The Department's opinion is based upon the field being used by 12 year olds and younger. This field will be used by 12 year olds and younger and those up to the age of a young adult which requires a deeper field.

In conclusion, I ask that you take this information into consideration when making your decision. The bottom line in that the net cost for the added property of \$20,667.00 is not much to ask for and I ask for your support in authorizing its purchase with funds taken out of the General Fund.


