ORDINANCE NO. 10-10-2

An ordinance to amend the Code of Ordinances to modify permit fees, Chapter 6, Article 2, Section 6-15. Fees.

WHEREAS, The St. Charles Parish Council amended permit fees pursuant to Ordinance No. 10-7-13; and,

WHEREAS, Modifications to the Fees are needed to adequately address all permit types.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the St. Charles Parish Code, Chapter 6, Article 2, Section 6-15(a) Permit, Plan Review, and Inspection Fees by Type be amended as follows (insert bold and delete strikethrough type):
