


Dear Constituent:

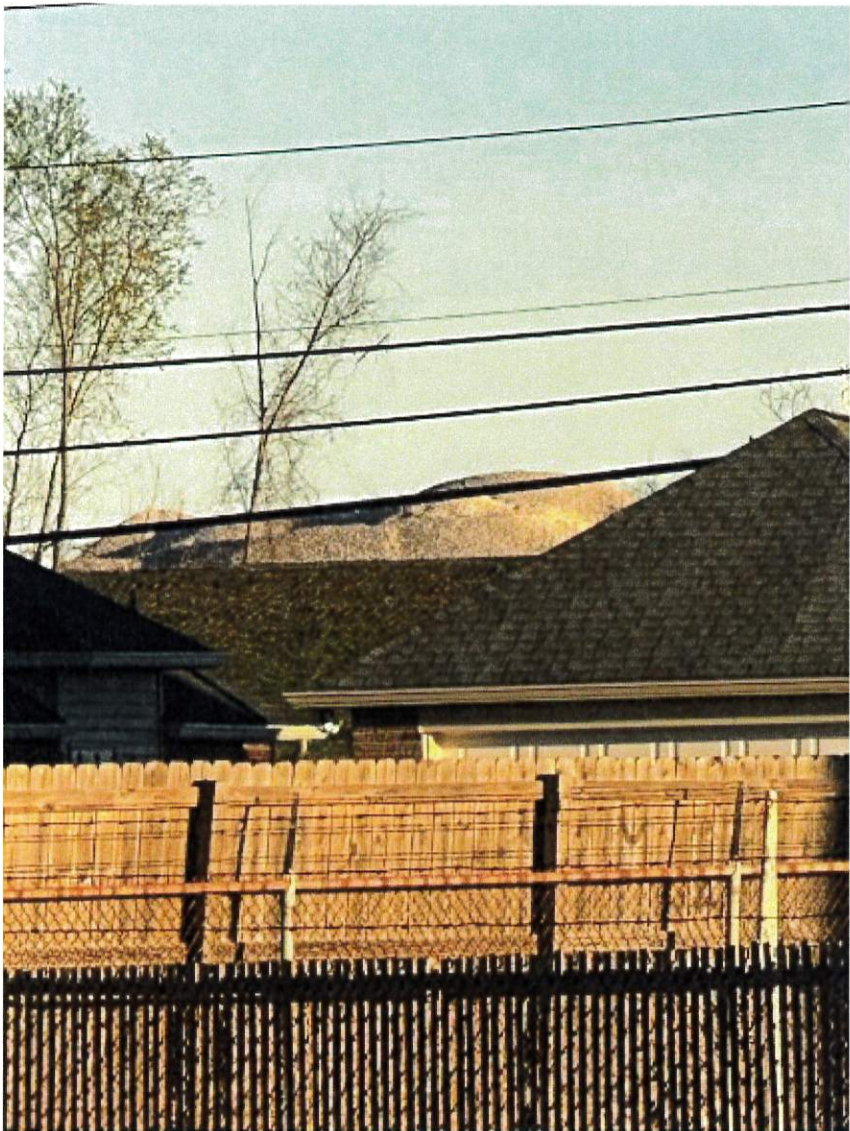

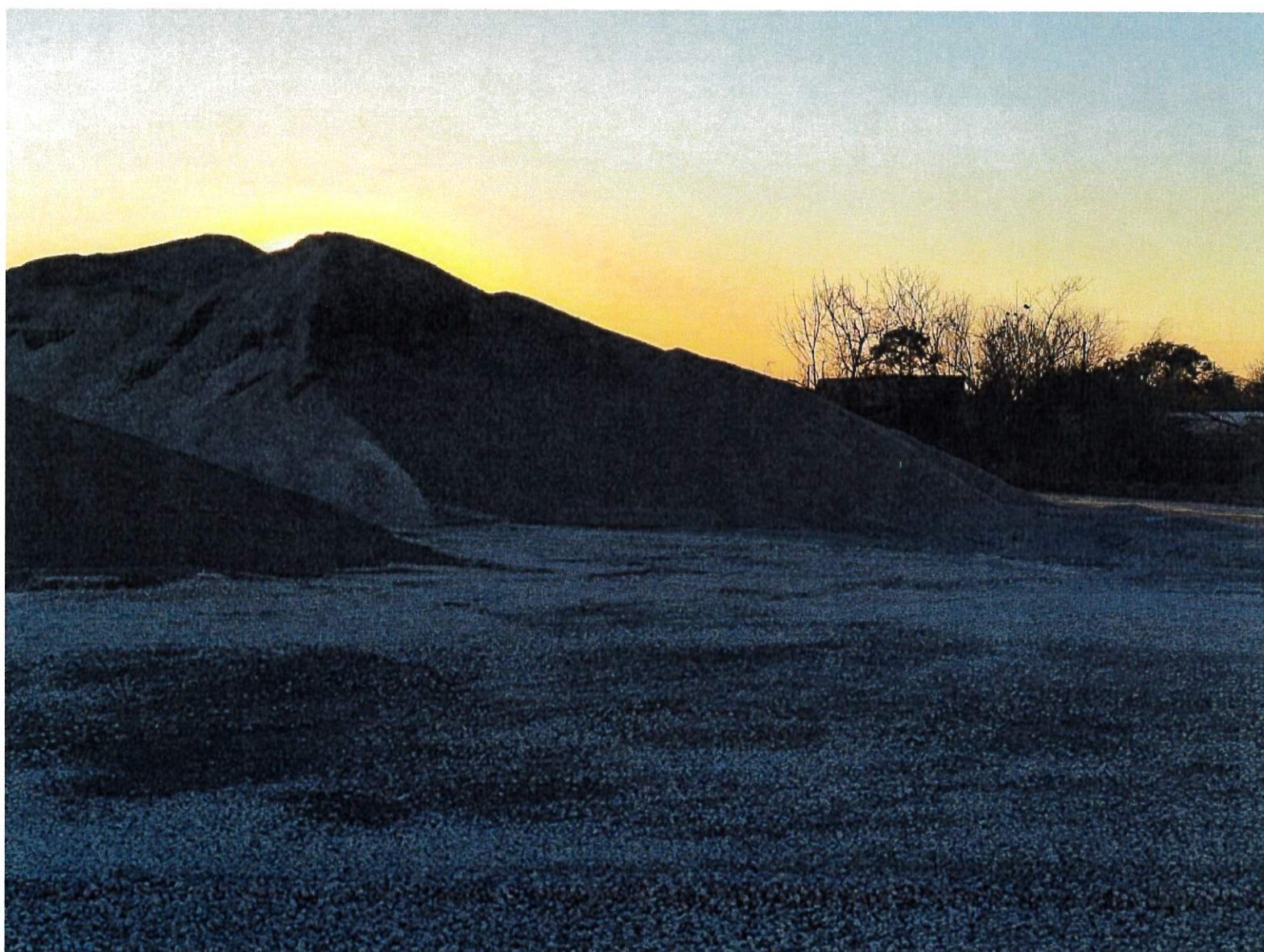
