The purpose of the Des Allemands Bulkhead — Phase II project is for St. Charles Parish to replace the existing bulkhead along Bayou Des Allemands by installing approximately 710 linear feet of 50' steel sheet piles between Old US 90 and the BNSF Railroad. This will also include the installation of up to four aluminum stop log flood barrier systems. To aid in installation of the sheet pile wall, some existing structures may need to be removed and replaced. Excavation, sand/clay backfill and flowable fill will be required along the new sheet pile wall to ensure all voids are properly filled and compacted. Utility penetrations through the sheet pile wall will be required for a minimum of water, gas and drainage pipelines. Potential asphalt/concrete roadway restoration
