ORDINANCE NO. 12-10-1

An ordinance to amend Ordinance No. 12-9-5 which waived local permit fees and some plan review and inspection fees contained within Chapter 6, Article 2, Section 6-15, for repairs and renovations required as a result of damage sustained from Hurricane Isaac, to extend the effective date through November 30, 2012.

WHEREAS, Ordinance 12-9-5, adopted on September 4, 2012, waived permit fees and some plan review and inspection fees for repairs and renovations required as a result of Hurricane Isaac through September 30, 2012; and,

WHEREAS, permits related to storm damage are still being filed; and,

WHEREAS, the Council wishes to extend the fee waiver through November 30, 2012.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That Ordinance No. 12-9-5 is hereby amended in Section I to read as follows:

SECTION I. That the Planning and Zoning Department is hereby authorized to waive permit fees contained within Chapter 6, Article 2, Section 6-15, for repairs and renovations required as a result of damage sustained from Hurricane Isaac, effective immediately and lasting through November 30, 2012.

SECTION II. That Ordinance No. 12-9-5 is hereby amended in Section II to read as follows:

SECTION II. That the Planning and Zoning Department is hereby authorized to waive plan review and inspection fees for trade permits (electrical, plumbing, gas and mechanical) and re-roofing permits (non structural) required as a result of damage sustained from Hurricane Isaac, effective immediately and lasting through November 30, 2012.
