ORDINANCE NO. 99-12-22

An ordinance to amend Ordinance No. 80-7-4, as amended, to revise the formula utilized to distribute funds to the Parish Volunteer Fire Departments.

WHEREAS, The St. Charles Parish Council has contracted with the St. Charles Firemen's Association, Inc., to provide Fire Protection to St. Charles Parish; and

WHEREAS, The St. Charles Firemen's Association, Inc., by letter dated September 23, 1999, has requested that the Parish Council revise the formula utilized to distribute funds to the Parish Volunteer Fire Departments.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That Ordinance No. 80-7-4, as amended, is hereby amended by revising Section (L) as stated in the attached Contract Amendment.

SECTION II. That the Parish President is hereby authorized to execute the attached Contract Amendment, as amended above, on behalf of the Parish of St. Charles.

"CONTRACT AMENDMENT"

UNITED STATES OF AMERICA  
STATE OF LOUISIANA  
PARISH OF ST. CHARLES

BE IT KNOWN, that on the 12<sup>th</sup> day of January, <sup>2000</sup>1999, appeared the following:

THE ST. CHARLES PARISH COUNCIL, herein represented by Chris A. Tregre, Parish President, hereinafter referred to as "Parish", and

THE ST. CHARLES FIREMEN'S ASSOCIATION, INC., herein represented by its President, Richard E. Bordner, pursuant to a resolution of its Board of Directors dated September 9, 1999, hereafter referred to as "Association",

Who declared that on July 7, 1980, the parties hereto entered into a contract which was adopted by Ordinance No. 80-7-4 and which, in part, allocated certain percentages of sales tax revenues to be apportioned between the fire departments that make up the membership of the St. Charles Firemen's Association, Inc.

That Ordinance Numbers 83-6-2 adopted June 6, 1983, 86-8-2 adopted August 4, 1986, 87-6-11 adopted June 15, 1987, 89-11-1 adopted November 6, 1989 and 94-9-12 adopted September 19, 1994, amended Section (L) of the contract to re-allocate the distribution of funds among the member departments.

That the parties hereto do appear to again amend Section (L) of the contract which allocates the monthly base amount and the percentage of remaining funds distribution to the member departments of the Association so that Section (L) will read as follows:

SECTION (L) The funds are to be distributed monthly by the Parish President to the individual members of the Association on the following basis:
